

## **Information on data processing (not legally binding translation)**

### **How long will the personal data be processed**

The personal data of the data subject will be deleted or blocked as soon as the purpose of the storage ceased to exist. This will happen once the research and related activities have been completed. The latest date of deletion is 12/31/2024.

### **Legal basis for processing**

### **Information about the rights of the data subjects**

If personal data is processed by you, you are i.S.d. DSGVO and you have the following rights to the responsible person: Due to the non-traceability of the data, you can not require the person responsible to confirm whether personal data concerning you is processed by us. You can request general non-personal information from the person responsible for the following information: the purposes for which the personal data are processed; the categories of personal data that are processed; the recipients or the categories of recipients to whom the personal data relating to you have been or will be disclosed; the planned duration of the storage of your personal data or, if specific information is not available, criteria for determining the duration of storage; the existence of a right to rectification or erasure of personal data concerning you, a right to restriction of processing by the controller or a right to object to such processing; the existence of a right of appeal to a supervisory authority; all available information on the source of the data if the personal data are not collected from the data subject; the existence of automated decision-making including profiling under Article 22 (1) and (4) GDPR and - at least in these cases - meaningful information about the logic involved, and the scope and intended impact of such processing on the data subject. You have the right to request information about whether the personal data relating to you are transferred to a third country or an international organization. In this regard, you can request the appropriate warranties in accordance with Art. 46 GDPR to be informed in connection with the transfer.

This right to information may be limited to the extent that it is likely to render impossible or seriously affect the realization of the research or statistical purposes and the restriction is necessary for the performance of the research or statistical purposes.

### **Information about the right to revoke consent**

A right of rectification and / or completion to the controller, if the processed personal data that concern you are incorrect or incomplete, can not be granted due to the non-traceability of the data.

### **DPA (Datenschutzbehörde)**

Without prejudice to any other administrative or judicial remedy, you shall have the right to complain to a supervisory authority, in particular in the Member State of its place of residence, employment or the place of the alleged infringement, if you believe that the processing of the personal data concerning you is violates against the DSGVO.

The supervisory authority to which the complaint has been submitted shall inform the complainant of the status and results of the complaint, including the possibility of a judicial remedy pursuant to Article 78 of the GDPR.
